Dosage: Preventative: Begin use 2-4 weeks before the onset of the allergy season by taking *Allergy Complex* 2 times per day. This will increase resistance to pollens before they even start. Keep taking throughout the allergy season. Results can vary from a percentage decrease in reactivity to complete eradication of symptoms.

Acute Allergies: The dosage here needs to be from 3-4 times per day until symptoms begin to subside. Stopping an acute allergy attack with herbs is more difficult, but is still possible
